## Types of Information

We receive, collect, and store any information you enter on our website or provide us in any other way. In addition, we collect the Internet protocol (IP) address used to connect your computer to the Internet. We may use software and marketing tools to measure and collect session information, including page response times, length of visits to certain pages, page interaction information, and methods used to browse away from the page as well as location. We also collect personally identifiable information (including name, address, email, communications); payment details (including credit card information), only through form submission or by making a payment through our website.

## How we collect & Store information

When you conduct a transaction on our website, as part of the process, we collect personal information you give us such as your name, address, and email address. Your personal information will be used for the specific reasons stated above only.

Our company is hosted on the Wix.com platform. Wix.com provides us with the online platform that allows us to sell our products and services to you. Your data may be stored through Wix.com’s data storage, databases and the general Wix.com applications. They store your data on secure servers behind a firewall.

All direct payment gateways offered by Wix.com and used by our company adhere to the standards set by PCI-DSS as managed by the PCI Security Standards Council, which is a joint effort of brands like Visa, MasterCard, American Express and Discover. PCI-DSS requirements help ensure the secure handling of credit card information by our store and its service providers.

We collect such Non-personal and Personal Information for the following purposes:

1. To provide and operate services of customer assistance.
2. To provide our Users with the ability to purchase our products and offerings.
